The Russell County Fiscal Court held a called meeting on Tuesday, January 4 at 10:00 a.m. at the Russell County Courthouse. Those in attendance were County Judge Executive Gary Robertson, Magistrates Greg Popplewell, Brook Cochran, Ronald Johnson, Jimmy McQueary, Larry Holt, County Attorney Kevin Shearer and Assistant County Attorney Don Byrom.

APPOINTING OF PERSONNEL: Judge Robertson stated that he would like to hire a Deputy County Judge, Chris Ramsey, for \$300.00 per week. He read the duties of the position. He stated that although not required, he would like to have a vote to establish a salary for this position. Magistrate Johnson made a motion to establish the salary for Chris Ramsey. Magistrate McQueary seconded. The roll call was unanimous. Judge Robertson presented a list of employees for the County Judge's office. Magistrate Johnson made a motion to continue the employment of the persons listed. Magistrate Popplewell seconded. The roll call was unanimous. Judge Robertson asked to appoint Magistrate Johnson as Judge Pro Tem. Magistrate Holt made a motion to appoint with Magistrate Cochran seconding. The roll call was unanimous.

Judge Robertson presented a list of county employees and positions. Magistrate McQueary made a motion to continue the employment of the persons listed. Magistrate Popplewell seconded. The roll call was unanimous.

APPOINT BOARD AND COMMITTEE MEMBERS: Judge Robertson stated he would like to create a Recycle Committee and appoint to the committee Troy Meadows, H.M.
